2. The Trust has to arrange for qualified woman in charge i.e. she possesses the qualification prescribed for a mid-wife under the Bombay Nurses, Midwives and health Visitor's Act, 1954 or any laws corresponding to that Act in force in any part of the State or produces a certificate that she has undergone training for a period of not less than 18 month in a hospital, maternity home or nursing home approved in this behalf by the Chief Inspector, or produce a certificate that she has received training for pre-primary teacher in an institution approved by the State Government.
3. The Trust has to arrange for maintaining average 30 wards in this Creche, including washing of the children and their clothing with supply of milk and refreshments etc.

The Charitable Trust shall preferably from medical field is advisable. Such Charitable Trust shall visit or send their representative or inspection of proposed building at Bhusawal and suggest required arrangement as per The Factories Act 1948 and Rules there under the Charitable Trust has to run this crèche from 7.00 a.m. to 7.00 p.m. in the factory premises of Bhusawal Thermal Power Station.
