Subject: Regarding revision in post published vide Advt. No. 08/2019

With reference to the above subject an Advt. No. 08/2019 was published for various Non – Technical cadre posts with last date of application as 18.12.2019. Due Corona Pandemic and Administrative reasons the Online Exam / Assessment Centre exam is yet to be conducted for the same. Meanwhile, GoM vide G.R. dtd 25.02.2022 has issued guidelines regarding revised procedure to fill in reserved category posts for small cadres. Accordingly, below mentioned are changes & updates in the posts advertised vide Advt. No. 08/2019:-

A) Category wise Posts Cancelled :-

Due to the revision in reservation, the posts advertised for Executive Chemist, Asst. General Manager (F&A) and Senior Manager (HR) under ST, OBC and OBC category respectively are cancelled hereby. Since there was no vacancy advertised under "Open" category for the said posts, candidates who have applied under the said category, will get refund of fee amount in due course of time.

C) Category wise Posts reduced & Horizontal reservation changed:-


