**Sub :-Expression of interest for hiring of residential flats on leave & license basis for staff working in Bhira HPS at Bhira, Patnus, Rawalje, Pali Village Tal- Mangaon and Sudhagad Dist-Raigad.**

1. Through this EOI, MAHAGENCO intends to identify interested and capable parties for hiring of residential flats on leave & license basis for staff working in Bhira HPS at Bhira, Patnus, Rawalje, Pali Village Tal- Mangaon and Sudhagad Dist- Raigad.
2. After identifying prospective bidders through EOI process, the open tender for inviting bid will be initiated prescribing qualifying requirements as per procurement policy of the company leave & license & agreement will be made with most competitive bidder.
3. EOI process will be subject to verification of all information submitted at the discretion of MAHAGENCO.
4. MAHAGENCO reserves the right to reject/ accept or partially accept any or all applications, cancel/ withdraw the EOI process without assigning any reason whatsoever and in such case, APPLICANT shall not have any claim against MAHAGENCO arising out of such action.
5. The purpose of inviting this EOI is to identify the APPLICANTS through EOI who are interested for letting of residential flats on leave & license basis for staff working in Bhira HPS at Bhira, Patnus, Rawalje, Pali Village Tal-Mangaon and Sudhagad Dist-Raigad.
6. MSPGCL intends to hire residential flats on leave & license basis-30 Nos Residential Flats comprising of 21 Nos 1-BHK , 09 Nos 2-BHK , from the individual /Govt/ Private Firms/ Builders, etc., which are in ready to occupy condition/under completion preferably in single building / premises. The preferred location of the premises shall be within a distance of about 20 Km from Bhira tail race hydro power station, Rawalje Tal- Mangaon, Dist-Raigad.
7. The property has to be within 20 KMs radius distance from Bhira tail race hydro power station,Rawalje Tal- Mangaon, Dist- Raigad.
8. The property should not be older than 05 years.
9. The flats should be preferably located in single building or single premises and aged not more than 05 year old.
10. The area of 1BHK flats should not be less than 517 Sq. ft. and 2BHK should not be less than 775 Sq.ft. (As per existing Bhira quarters area)
11. The property should have all necessary approvals.
- 12.The property should be preferably ready to occupy immediately or within 1 month period. All flats & common area should be equipped with electrical equipments like tube, bulb, fan, geyser etc.
13. At the time of filling this EOI, the property should be vacant & not sold to anyone else.

14. The property shouldn't have any kind of legal attachments or claims pending in the name of the owner of the subject property.
15. The premises offered should be in good and ready to occupy condition. The owners of the premises will have to hand over the possession of premises immediately after the acceptance of their offer after submitted through open tender process by the department and execution of agreement.
16. The intending owner /Firm / Builder shall submit the application along-with following documents -
  - a) A set of plan, sections, elevations and site plan of the premises offered showing the details dimensions, main approach road, road on either side if any, and adjacent properties etc. around the properties.
  - b) Floor plan of premises offered along-with list of amenities /furniture available.
  - c) A copy of the title investigation and search report along with copies of title deed documents.
  - d) Photograph of building and premises showing relevant details.

- **EOIS from intermediaries or brokers will not be entertained.**
- **The MSPGCL reserves the right to accept any or to reject any or all OFFERS at his sole discretion without assigning reasons thereof.**
- **Bidder should have:-**

- A) Initial deposit payment will be made to the bidder after acceptance of his offer in the form of cheque at the time of the agreement
- B) Agreement period : 2 year from the date of actual possession of the flats
- C) Termination of the agreement :-
  - 1) Mahagenco will terminate agreement with the notice of one month.
  - 2) Bidder can terminate the agreement with the notice of 4 months after expiry of one year.
  - 3) Bidder cannot terminate agreement before one year. In case bidder wants to terminate the agreement after one year then also bidder should serve notice of termination before 4 months.

- D) Procedure of handing over of the flats to the bidder in case of expiry of the agreement or termination of the agreement.  
Bidder should refund the entire initial deposit amount to Mahagenco. After realization of the amount by Mahagenco, Keys of the flats will be handed over to bidder.
- E) Further, electricity bills dues and any other dues will be cleared during the handing over of the flats to bidder.
- F) Bidder should ensure the availability of the following facilities during the agreement period
- 1) Water supply and common area lighting.
  - 2) Electricity supply of the flats & common area in case fault is in the premises of the buildings.
  - 3) Lifts in working condition.
- G) Penalty  
In case bidder fails to maintain above facilities for consecutive period of 12 hours then Penalty at the rate Rs. 500 + applicable GST for each 24 Hours will be recovered from the bidder. Further, in such case Mahagenco restores above facilities with incurring expenses then such expenses will be recovered from the rent payable in the ensuing month to the bidder.
- H) Rent payment on monthly basis will be made to the bidder within 45 days after submission of the rent bills by bidder. Rent bill will be certified by the Civil section after verifying the availability of the common facilities in the premises as mentioned in (F) above  
Electricity bill of the individual flat will be paid by the employee residing in the flat or in case flat is vacant then same will be paid by Mahagenco.
- I) Mahagenco will decide about the allocation of the flats and bidder will not interfere in such allocation.
