Preamble:-

Chandrapur Super Thermal Power Station is the biggest power station of MSPGCL with a capacity of 2920 MW. It comprises of 2 units of 210MW each & 5 units of 500 MW each. CSTPS shares electricity 28% of total requirement of Maharashtra state by MSPGCL. Continuous electrical power generation 24X7 is always there. This highlights the importance of CSTPS in the power sector of the state.

Total employees working at CSTPS are 2200 no's (approx.) and contract labour 4000 (approx.). Canteen service is required at CSTPS employees & contract labour works in shift wise.

Requirement:-

From 2015 Indian Coffee House was providing canteen services at plant and contract was approved by HO for every three years period.

Vide letter at ref (3) Ho has directed for process the next proposal through open tender or EOI for running of U-210,500 & U-8&9 canteen. Accordingly this proposal is prepared & based on the last work order for one year.

Justification: -

The canteen is run departmentally as a measure of Staff Welfare. There is a need to prepare and make available various items of beverages, snacks and meals for the staff at economic rates. For this purpose, CSTPS constructed the necessary place for refreshment at 210 MW, 500 MW & at Unit 8&9 for Officer's, Staff, Contract labour's. The corporate office signed MoU for "Running of U-210,500 & U-8&9 canteens at Chandrapur Super Thermal Power Station" according to ref (1) & (2) which validity is up to 31/12/2025. Hence, EOI prepared & enclosed herewith.

Budget provision: - The budget provision is made in FY 2025-26 under budget code 76 group.

DOP Clause: - Section- II, dated 01/07/07, clause no. 2.2.1, remark no. 4 & 15, and as per revised DoP Office memorandum letter no. DOP/Dir (FIN)/23-24/1741 Dtd. 01/08/2023 CE (O&M) in consultation with GM (F&A) is the competent authority.

Proposal: - As such it is proposed to accord approval for calling EOI and placing purchase order for "Running of U-210,500 & U-8&9 canteens at Chandrapur Super Thermal Power Station".

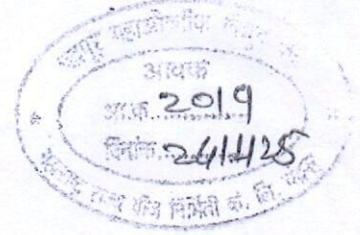

SCOPE OF WORK AND TERMS & CONDITIONS OF CONTRACT

NAME OF WORK: Running and Maintenance of Plant Canteens and Site Service pantries at Chandrapur Super Thermal Power Station for Period of one (01) Year.

1. DEFINATION:

1.1 Chandrapur Super Thermal Power Station within the scope of this tender shall mean the concern Power Stations having its registered office at Prakashgad, Bandra (E), Mumbai-51, and shall include their legal representatives, successors and permitted assigns.

1.2 The Contractor within the scope of this tender is the vendor who is awarded the contract by Chandrapur Power Stations for running the Canteen in Chandrapur Super Thermal Power Station Premises and precincts at CSTPS.

1.3 Contract means the Notice Inviting Tender, the tender and acceptance thereof and the formal Agreement, if any, executed between Chandrapur Super Thermal Power Station and the Contractor together with General Conditions, Special Conditions, Schedule of quantities with rates, Instruction to tenderers etc. All these documents taken together shall be deemed to form one Contract and shall be complementary to one another.

2. INSPECTION OF SITE:

2.1 Indenting tender may visit the Canteen Site (s) and make themselves conversant with the Site conditions. Additional clarifications/ information, if any, regarding the site (s) and other particulars, may be obtained from Chief Engineer, Chandrapur Super Thermal Power Station.

2.2 Notwithstanding 2.1 above, it will be deemed that the participant tenderer have visited the site and familiarized themselves with all other terms and conditions and which may have appeared on their tender.

3. FACILITIES:

3.1 Chandrapur Super Thermal Power Station agrees to provide the following facilities to the Contractor.

3.2 Required furniture like tables and chairs with a capacity to accommodate about 150 employees at a time.

3.3 Utensils required for cooking as well as for serving the meals, tiffin, shall be provided.

3.4 Chandrapur Super Thermal Power Station shall provide the Building for canteen for nominal rent Rs. 1 per month.

3.5 Water and electricity will be supplied contractor free of cost for running Canteen.

3.6 The canteen premises will be the possession of Chandrapur Super Thermal Power Station and the contractor is permitted to enter the premises only to run the canteen. If at any time, the contract is terminated or the period of contract comes to an end, or if, Chandrapur Super Thermal Power Station decides that the contractor should not be allowed to run the Canteen, in that event, Chandrapur Super Thermal Power Station will be entitled to restrain the permission granted to the contractor to supply articles as per the terms of the contract.

3.7 The contractor shall be responsible for the safe custody of all the items of furniture, cutlery, Utensils, kitchen equipment etc. And shall handover the same to Chandrapur Super Thermal Power Station as and when demanded. Any Loss/Breakage to these items shall be at the cost and in the manner as may be decided by Chandrapur Super Thermal Power Station. In case, the Contractor fails to make good the aforesaid losses, concern Power Stations shall be entitled to recover the replacement cost as decided by Chandrapur Super Thermal Power Station from the security deposit of the contractor.

3.8 The contractor shall use the canteen for the purpose of this agreement only and he shall not make or permit to make any structural additions or alternations to the same without prior approval in Writing, of the Chandrapur Super Thermal Power Station.



3.9 The contractor shall not resist, at any time, to allow the authorized representative of the Chandrapur Super Thermal Power Station to enter the canteen premises in order to inspect and execute the Structural additions, or repairs to the buildings electricity conditions, water and sanitary fitting from Time to time.

4. TAXES: Taxes as applicable in Maharashtra State shall be reimbursed as per actual in addition to the yearly total contract price on production of documentary proof.

5. RISK AND COST:

5.1 In case the contractor fails to supply the food items or snakes or beverages etc. Or fails to meet the Obligation as per the terms of the contract agreement, Chandrapur Super Thermal Power Station shall be at liberty to take services etc. From elsewhere at contractor's risk and cost and the extra amount, if any, spent by Chandrapur Super Thermal Power Station in this account shall be recovered from the contractor from any amounts due to him and or from security deposit.

6. RATES:

6.1 The contractor shall have to offer the minimum item wise rates for various catering items and services as decided by the Canteen Management Committee.

6.2 The approved rates of all the items shall have to be displayed on the Notice Board at the conspicuous place in the Canteen by the contractor.

6.3 The contractor shall provide the food items to the employee approved rates.

6.4 The contractor will also be required to provide canteen facilities on Sunday/ Holidays at the same rates.

6.5 Menu may be changed from time to time depending upon seasonal requirement.

7. SERVICE TIMINGS AND SERVICING PAPTICULAR:

7.1 The contractor shall provide catering services on all working days of the year in such times and places as Decided by Chandrapur Super Thermal Power Station from time to time.

7.2 The contractor shall have to supply and serve tea, coffee, snacks etc. at the Conference Halls at Administrative Building and other building, at Plant locations, Hospital, Township, during meetings, seminars, training programs etc. as and when required by the Chandrapur Super Thermal Power Station.

8. CLEANLINESS, HYGIENE AND QUALITY ASSURANCE:

8.1 The contractor shall maintain the canteen in clean, hygienic and sanitation conditions. Sterilization method should be observed in cleaning various vessels, plates, etc. The contractor shall use adequate quantities of cleaning powder, phenyl, etc., for cleaning the floors of the canteen, the satisfaction of the premises in the Canteen building to the satisfaction of the Chandrapur Super Thermal Power Station Management, the Chandrapur Super Thermal Power Station Management without giving any notice will be entitled to cancel the contract. The decision of the Chandrapur Super Thermal Power Station Management in this regard is final and binding on the contractor.

8.2 The contractor will have to ensure cleanliness in entire canteen area including disposal of garbage at identified place, kitchen areas and adjoining areas. They have to deploy sufficient cleaning staff, with required tools & tackles for this purpose and to the appreciable satisfaction of Chief Engineer, Chandrapur Super Thermal Power Station.

8.3 The contractor shall arrange to purchase and provide the raw materials for all the items of acceptable standard quality for use in the Canteen at their own cost and that the contractor shall abide by the local Government laws relating to the sale of food, drinks, etc., and shall obtain the necessary license (s) from the competent authority. Ingredient to be used for various items, as listed below, may be considered as the quality requirement.

8.4 Details of the Brands to be used for Raw Materials: The contractor shall be required to use raw materials of the following make for preparation of food/beverage items.

- (i) Rice : Basmati Quality, or as instructed by the Officer-in-charge.
- (ii) Dal : Good Quality or as instructed by the Officer-in-charge
- (iii) Milk : Mother Dairy or equivalent or as instructed by the Officer-in-charge.



- (iv) Tea : Tata tea or any other brand - as specified by the Officer-in-charge.
- (v) Coffee : Coffee powder of Nescafe/Bru Coffee, or as instructed by the Officer-in-charge
- (vi) Oil : Refined (Agmark)/ Sunflower / Dhara / equivalent of good quality (Agmark)
- (vii) Ghee : Agmark or as instructed by the Officer-in-charge
- (vi) Vegetables: Fresh vegetables
- (ix) Atta : Shakti bhog brand (Agmark)/ Rajdhani Brand, any other Agmark approved good Quality Atta (flour), as instructed by Officer-in-charge.
- (x) Maida : Stag brand - Delhi Flour Mill (Agmark)/ Rajdhani(Agmark)/ any other Agmark Approved brand Maida shall be used in the canteen for preparation food items.
- (xi) Besan : Rajdhani brand (Agmark)/ Kailash brand (Agmark)/ any other Agmark brand of Good quality shall be used in the canteen for preparation of food items.
- (xii) Bread : Britannia/Modern/Perfect brand of bread shall be used in Canteen for Preparation of food items. Fresh baked bread of reputed bakery.
- (xiii) Lijjat Papad of Chapati size shall be provided.
- (xiv) Whenever spices and masala are used, they should be branded and of good quality or as Instructed by the Officer-in-charge.

8.5 The contractor has to ensure purchase of raw materials, its transportation and allied activities with their own manpower and cost.

8.6 The Chief Engineer, Chandrapur Super Thermal Power Station or his authorized representative will be entitled to inspect the kitchen or the place where meals, snacks, etc., are prepared and will also be entitled to inspect the raw materials to be used for the aforesaid purpose. In the event of Rejection of any raw materials by the representatives of Chandrapur Super Thermal Power Station the contractor shall not use the rejected materials for preparation and shall not supply the Food prepared out of such rejected materials. Chandrapur Super Thermal Power Station shall not be responsible for any loss incurred by the contractor on this account.

8.7 Chandrapur Super Thermal Power Station will have the right to order destruction of any raw Material/finished item is unhygienic/substandard with respect to brand /quality prescribed for the same. A fine of Rs. 500/- per day will be imposed if it is found that the raw material being Prepared / food item being served is of sub-standard and food items are not available.

8.8 If is found by Chandrapur Super Thermal Power Station that the food supplied by the contractor Is contaminated with an adulterated material, the contract shall be terminated immediately Without prejudice to the other legal right of the Chandrapur Super thermal Power Station, Not Withstanding the above, the contractor shall also be solely held liable for any legal action as Contemplated under various laws including Prevention of Food Adulteration Act.

8.9 The Contractor shall not exhibit or cause to exhibit in the Canteen premises any printed or Written notice or advertisement of any kind whatsoever without the written permission of the Chief Engineer, Chandrapur Super Thermal Power Station or authorized representative.

8.10 The quality of food materials, tea, coffee, snacks, etc., including the quality of the raw material to be used in the preparation of the food items, should be of acceptable standard quality which is Subject to the inspection by the Chandrapur Thermal Power Station authorized representative in Order to ensure that items served by the contractor are of acceptable standard quality.

8.11 The Contractor shall not be allowed to take eatables and other material outside the premises of The establishment except with the written permission of the authorized representatives of Chandrapur Super Thermal Power Station.

9. CANTEEN STAFF AND LEGAL COMPLIANCES:

9.1 The Contractor shall recruit his own staff for cooking, serving , cleaning etc, at his cost and risk and the contractor shall be cleaning etc, at his cost and risk and the contractor shall be responsible for fulfilling the requirement of all the statutory provisions of minimum Wages Act, Contract labour (R&A) Act, Payment of provisions of Minimum Wages Act, Contract labour (R&A) Act, Wages Act, Payment of gratuity Act, ESI Act, workmen's Compensation Act and Shops and Establishment Act in respect of the staff employed by him.



9.2 The Contractor will have to deploy sufficient cooking staff for cooking the various items so as to ensure proper quality and the required quantity.

9.3 The Contractor will be required to issue uniform to its staff and ensure that the same is being worn by its staff and being cleaned regularly.

9.4 None of the employees engaged by the vendor should be below 18 years of age.

9.5 The Contractor shall be responsible for conduct and behaviour of their staff and any loss or damage to the movable or immovable property issued to them. If there is any loss or damage, it will be recovered from the contractor accordingly.

9.6 The Contractor shall indemnify CSTPS and the employees of the contractor against any accidents and injuries. In case, any compensation for any accident /injures to any of the contractor's employees becomes payable by Chandrapur Super Thermal power Station, the same shall be recovered, from any sums/amount due to the contractor or the security deposit.

9.7 The Contractor shall arrange for proper maintenance and cleanliness of the uniforms, issued to the Staff working in the canteen.

9.8 For the purpose of canteen, the contractor shall engage such adequate number of employees (in Different categories) as may be required, to meet the requirement of services etc. In case, Chandrapur Super Thermal power Station finds that the required number of employees is not being engaged in sufficient numbers in one or more in the respect. Chandrapur Super Thermal Power Station and required in this respect.

9.9 All the staff of the contractor required to work in the canteen shall be physically and mentally fit and shall be free from all communicable, contagious infections and other diseases and shall present themselves to the Chandrapur Super Thermal Power Station medical officers from time to time for medical examination as may be required and decided by the concern Power Stations.

9.10 If in the opinion of Chandrapur Super Thermal Power Station, any employees or employees of the contractor is/are found to be suffering from any disease, or if any employees is found to commit any misconduct or to misbehave, Chandrapur Super Thermal Power Station, at its sole discretion, may require the contractor to remove such employee or employees, and the contractor shall remove such employee, employees, without questioning the decision of Chandrapur Super Thermal Power Station in this respect and Chandrapur Super Thermal Power Station will be entitled to restrain such employees from entering the canteen premises.

10. PERIOD OF CONTRACT:

The period of license shall be 12 month (one year) from the date of start which will be decided by Chief Engineer, Chandrapur Super Thermal Power Station.

11 TERMINATION/MODIFICATION :

11.1 Chandrapur Super Thermal Power Station shall have the right to terminate/modify the contract before the expiry of the contract without assigning any reason by giving a prior notice of 30 days and the contractor shall not have any claim against Chandrapur Super Thermal Power Station for such Termination.

11.2 If, at any time, it is found that the quality and quantity of food stuffs supplied by the contractor or the services by the contractor are unsatisfactory or that the contractor has violated the terms and conditions of this agreement, Chandrapur Super Thermal Power Station reserves the right to terminate the contract at any time.

11.3 In the event of the contractor committing any breach of any terms and conditions contained herein and or required to be observed and performed by the contractor, Chandrapur Super Thermal Power prejudice to the right and remedies available to Chandrapur Super Thermal Power Station against the contractor.

11.4 On expiry or termination of this contract, the contractor shall pay to Chandrapur Super Thermal Power Station all dues as may be payable by him to Chandrapur Super Thermal Power Station and handover the canteen premises with all fitting and fixtures and all utensils, furniture, kitchen equipment, etc., which have been issued initially and also from time to time. In case of default by the contractor, Chandrapur Super Thermal Power Station shall be entitled to recover such dues and cost from any amount due to the contractor.
