#### 4.0 Minimum Qualifying Requirements for the Bidders:

The Bidder should meet the following qualifying requirements:

- (A) Average Annual financial turnover for any 3 years during last five
   (5) years, ending 31<sup>st</sup> March of the previous financial year, should be at least 30% of the estimated cost with UDIN.
  - (B) Experience of having successfully completed similar works during last nine (9) years ending last day of month previous to the one in which applications are invited should be either of the following: -
  - i) Three similar completed works each costing not less than the amount equal to 40% of the estimated cost

ii) Two similar completed works each costing not less than the amount equal to 50% of the estimated cost

#### OR

- iii) One similar completed works each costing not less than the amount equal to 80% of the estimated cost
- 4.2 Similar work means "the bidder should have experience of disposing off radioactive material/Nucleonic density meters and erection of low radiation Nucleonic density meter".
- 4.3 In addition to the above, the criteria regarding satisfactory performance of works, personnel, establishment, plant, equipment etc. may be incorporated according to requirement of project.

#### 4.4 ADDITINAL REQUIREMENT:

- a) The bidder should produce the copies of statement of Annual Accounts for previous three/five years duly certified by a Chartered Accountant or produce a certificate of annual turnover during previous three / five years duly certified by a Chartered Accountant with UDIN.
- b) The bidder should submit the latest (drawn in current financial year) solvency certificate for 100% of estimated amount from any Nationalized or Scheduled bank.
- c) Goods & Service Tax Registration Certificate.
- 4.5 If the bidder does not upload all valid documents as above, then his bid will be liable for Rejection. The bidder must fulfil the above qualifying requirements up to last day of submission of the bid.
- 4.6 It is mandatory for vendor to visit the site, to study the existing scheme and locations of the existing system and to get actual data of measurement; bidder has to submit the site visit report along with

technical bid. This is also mandatory document for evaluation and qualification purpose.

- 4.7 The Bidder shall visit and study the site on his own cost with prior permission from Ex. Engineer, Parli Project. Submitted details shall guarantee the inside design conditions as specified. Any other information required by the contractor for verification shall be provided to him by the contract operating authority.
- 4.8 Notwithstanding anything stated above, the Owner reserves the right to undertake a physical assessment of the capacity and capabilities including financial capacity and capability of the Bidder to perform the Contract, should the circumstances warrant such assessment in the overall interest of the Mahagenco. The physical assessment by the Employer shall include but not be limited to the assessment of the office/facilities/banker's/reference works/ similar project being executed by Bidder. A negative determination of such assessment of capacity and capabilities may result in the rejection of the Bid. The above right to undertake the physical assessment shall be applicable for the Qualifying Requirements stipulated in IFB.

#### 5.0 TENDERING PROCESS:

- 5.1 Single Tender (E-Bid) for 1x250 MW, Unit-8 of Parli Thermal Power Station is invited from eligible Indian Bidders on single stage, two envelope bidding basis. Envelope-I Techno-commercial Bid and Envelope-II Price Bid for the brief scope of work mentioned in relevant sections.
- 5.2 Selection of successful bidder for award of contract shall be done as detailed in Clause No. 24.0, Section-I of the bid specifications.
