a. Eligibility for Bid Participation:

Any buyer who

- is Indian entity
- is registered as per specified guidelines for registration with e-tender platform of Mahagenco
- has submitted the tender fee as per applicable terms
- has submitted the Bid Security /EMD as per the applicable terms
- has submitted documents [online at e-auction platform/ tender platform, as per tender documents] before the last day of submission of documents and found correct as per terms and conditions of the e-tender

b. Documents to be Submitted [online]:

- III. Company Registration, as may be applicable
- IV. 'Power of Attorney of the Authorized Person' signing and submitting the documents.

- VIII. Bidder Details (Annexure-II)

c. **Consortium / JV:**

Consortium /JV is not allowed.

d. **Bidder's Past Record:**

On the due date of submission of the bid,

- (a) The bidder including any of their affiliates should not have been blacklisted / banned for participation by any **Govt. entities, or semi- Govt. entities or other companies.**
- (b) Penal action such as termination / foreclosure of contract/(s) on account of non-performance of contractual obligations should not have been taken against the bidder by **Govt. entities, or semi-govt. entities or other companies.**

If the documents submitted against "Bidders Past Records" are found misleading during scrutiny, the bidder will not be considered for qualification and any explanation shall not be accepted.

- 1) The above qualifying requirements are to be read in totality and not in isolation.
- 2) Mahagenco reserves the right to seek any additional information as it may deem fit to satisfy itself with the eligibility and past performance of the bidder.
- 3) In case, it is found that the bidder has submitted the false information against Qualifying Requirements, then Mahagenco may forfeit the EMD and take action as deemed fit.
