Qualifying Requirement of E-auction of 20% Quota Dry Fly Ash:

A. Qualifying Requirement.

1. **Nature of Business:** Bidder Should be ash product manufacturer (i.e., manufacturer of bricks, sheets, blocks tiles, construction products, wall panels, cement sheets etc.) with SSI / DIC Certificate.
2. Bidder should produce relevant license for their business (i.e., consent to operate) from Pollution Control Board of respective area.
3. Bidder should produce documentary evidence regarding Consumption capacity for qualifying for e-auction of 20% Quota Dry fly ash.
4. Bidders manufacturing unit should be located within 300 KM radius of respective TPS.
5. Following documents will be considered for making the bidders eligible for ash allocation under 20% quota:
 - i. Valid consent to operate from MPCB.
 - ii. Certificate from District Industries Centre regarding Manufacturing of fly ash or clay-fly ash bricks, block and tiles.
 - iii. Undertaking regarding purpose of use of fly ash on Rs. 100/- Bond paper.
 - iv. Monthly GSTR-3B with ARN E-mail showing Monthly sales figure and GST paid thereon.
 - v. Monthly or quarterly GSTR-1 or GSTR-4 whichever is applicable showing sales effected with the unit and GST liability thereon.
 - vi. Copies of six monthly and annual Manufacturing Account, Profit and Loss account, Balance Sheet and Yield statement of the unit duly certified by a chartered accountant.
 - vii. No objection certificate from respective Village-Council / Municipal Corporation.
 - viii. 7/12 extract in the name of business.
 - ix. PAN Card in the name of business.
 - x. Electricity bill of business area.
 - xi. Map showing the distance of manufacturing unit / plant of applicant from TPS.

B. Estimated Yearly Quantity and base rate.

- All Bidders shall bid for min 100 MT and in multiple of 10 MT up to max quantity (E).

C. Terms and Conditions

- Bidder have to register on Metal Scrap Trade Corporation Ltd (MSTC) portal for participation in e-auction.
- Bidder should be ash product manufacturer (i.e. manufacturer of bricks sheets, blocks, tiles, construction products wall panels, cement sheets etc.) with SSI /DIC certificate.
- Bid evaluation and rate applicability shall be strictly as per QR documents and bid document and decision by the auction committee in this regard shall be final and binding on all bidders.
- **EMD:** Rs. 10,000/- is to be deposited to MAHAGENCO account details mentioned.
- **Security Deposit:** - 5% of the annual order value limited up to Rs. 1 Lakh.
- **Penalty:** -Penalty for short Lifting at rate of Rs. 10/MT for non-lifted quantity to be calculated quarterly.
- If any agency fails to lift **70%** of the allotted quantity consecutively for the period of Three months, the sale order will be terminated.
- Total Balance quantity (unlifted by agency, balance quantity after e-auction, balance quantity after termination) will be made available to the demanding agencies at TPS wise Highest quoted rate in e-auction on **First come first serve basis**.
- Minimum quantity of 100 MT on yearly basis is assured quantity to the qualified bidders. Above 100 MT, the quantity will be allocated proportionately if total demanded quantity is more than the available quantity and according to bidder SSI unit capacity after physical inspection and verification at site .
- Bidders may quote the annual quantity required against a price starting from floor price and with increment for bidding of Rs. 1.00.
- **Contract period:** One year from the date of issue of order.
- There will be no lower limit for bid evaluation below which the tender will be declared unsuccessful.
- All successful bidders should quote to match the rate with H1 bidder of the TPS wise respective slabs in the following manner.

- The allocation of fly ash shall be given as per availability of dry fly ash. No claim shall be made to PARAS TPS , MSPGCL against the non- availability & quality of dry fly ash on any particular day. The rates applicable are subject to change as per instructions/guidelines from MSPGCL H.O.
- Compliance of all pollution norms as prescribed by MPCB / CPCH / RTO etc as far as loading and transportation of FLY Ash is concerned. If any damages happens to MAHAGENCO properties, agency shall be held wholly responsible for the same and damages will be recovered from the agency.
- Only those vehicles are allowed, which followed protocols of ash transportation and ash lifting.
- All machines / vehicles shall have valid RTO registration / agreement . All vehicles should have valid insurance. All vehicles drivers should have valid Licence.
