- **B1: Qualifying requirement**

1. Nature of Business: Bidder should be ash product manufacturer (i.e. manufacturer of bricks, sheets, blocks, tiles, construction products, wall panels, cement sheets etc.) with MSME/ Udyam registration certificate.
2. Bidder should produce relevant license for their business (i.e consent to operate) from Pollution Control Board of respective area. Industries falling under White category shall be exempted from this condition only after producing the acknowledgement of self-declaration submitted to the MPCB thereby confirming to be in white category.
3. Bidder should produce documentary evidence regarding Consumption Capacity for qualifying for e-auction of 20% Quota Dry Fly Ash.
4. Bidders manufacturing unit should be located within 300 KM radius of Bhusawal TPS.
5. Following Documents will be considered for making the bidders eligible for the ash allocation under 20% quota:
 - I. Valid Consent to Operate from MPCB (white category industries shall furnish the acknowledgement of online submission to MPCB confirming to be in white category)
 - II. Certificate from District Industries Centre regarding Manufacturing of fly ash or clay -fly ash bricks, blocks and tiles.
 - III. Undertaking regarding purpose of use of fly ash
 - IV. Monthly GSTR-3B with ARN E-mail showing Monthly sales figure and GST paid thereon.
 - V. Monthly or quarterly GSTR-1 or GSTR-4, whichever is applicable , showing sales effected with the unit and GST liability thereon.
 - VI. Copies of six monthly and annual Manufacturing Account , Profit and loss account , Balance Sheet and Yield statement of the unit duly certified by a chartered accountant and must be "UDIN" generated.
 - VII. No Objection Certificate from respective Village -Council/ Municipal Corporation.
 - VIII. 7/12 extract in the name of business.
 - IX. PAN card in the name of business
 - X . Electricity bill of business area.
 - XI. Map showing the distance of manufacturing unit/ plant of applicant from TPS.

XII. Money Receipt for EMD paid, issued from Bhusawal TPS account section.

Note: All documents should be original scan documents and quality of scanning should be good and readable , otherwise NOT consider for bid.

B2. TERMS AND CONDITIONS

1. Bidders have to register on Metal Scrap Trade Corporation Ltd(MSTC) portal for participation in e-auction.
2. Bidder Should be ash product manufacturer (i.e. manufacturer of bricks , sheets, blocks, tiles ,construction products , wall panels, cement sheets etc) with MSME/Udyam registration.
3. Bid evaluation and rate applicability shall be strictly as per QR documents and bid document and decision by the auction committee in this regard shall be final and binding on all bidders.
4. EMD of Rupees 10,000/- The EMD paid only for “ Dry Fly Ash e-auction at Bhusawal TPS” will be accepted and EMD paid for other auction at Bhusawal TPS/ Other TPS will NOT be accepted.
5. Security deposit : 5% of the annual order value, limited to Rs 1lakh.
6. Penalty : Penalty for Short Lifting at rate of Rs 10/MT for non-lifting quantity to be calculated quarterly.
7. If any agency fails to lift 70% of the allotted quantity consecutively for the period of Three months , the sale order will be terminated.
8. Total Balance quantity (unlifted by agency , balance quantity after e-auction , balance quantity after termination) will be made available to the demanding agencies at TPS wise Highest quoted rate in e-auction on First come first serve basis.
9. Minimum quantity of 100MT on yearly basis is assured quantity to the qualified bidders. Above 100MT , the quantity will be allocated proportionately if total demanded quantity is more than the available quantity.
10. Bidders may quote the annual quantity required against a price starting from floor price and with increment for bidding of Rs 1.00
11. Contract period : One Year from the date of issue of order.
12. There will be no lower limit for bid evaluation below which the tender will be declared unsuccessful.
13. All qualifying bidders who match the rate of H1 bidder shall be allotted the proportionate of their bidding quantity.
- 14. All bidders shall bid for min 100MT and in multiple of 10 MT upto max quantity.**
