## **E-auction of 60% Pond Ash Bhusawal TPS**

### **A. Estimated Quantity and rate of pond ash**

#### **A1: Qualifying Requirement**

1. The minimum annual turnover of Bidder during any of the last three years should be Rs. 1 crore.
2. Bidder should have experience in lifting and transportation of pond ash.
3. Bidder should have at least One JCB/Pock lain machines (owned/hired). The machines/vehicles (owned/hired) shall have valid RTO registration
4. Bidder should have PAN and GST certificate of business.
5. The lead bidder may form consortium with max. 3 no. of other agencies to fulfill qualifying criteria.
6. Q.R. of at Sr no 1 and 2 is not applicable to bidders/ agencies like local affected Gram panchayat/local bodies.
7. Q.R. of turnover is not applicable to Local agencies located within 50 KM radius of respective TPS.
8. Bidder shall submit Valid MPCB Consent/ applicable statutory document based on the nature of activity:
  - A. Where bidder is engaged in manufacturing /processing/ industrial operation , bidder shall submit Valid Consent to Operate(CTO) issued by MPCB/ Concerned SPCB.
  - B. Where bidder shall falls under White Category , bidder shall submit Self-Declaration / Acknowledgement of online submission on MPCB portal confirming White Category status , as applicable.
  - C. As per Central Pollution Control Board (CPCB) guidelines and the MPCB Circular dated 16/06/2025. The circular clearly stipulates that activities falling under the White Category are considered non-polluting and do not require Consent to Establish (CTE) or Consent to Operate( CTO).
  - D. Trading activities , including buying, selling and handling of material without any manufacturing or processing , are not classified as industrial activities and hence do not require MPCB consent and are exempted from obtaining MPCB Consent.
9. Money Receipt for EMD paid, issued from Bhusawal TPS account section.

Note: All documents should be original scan documents and quality OR scanning should be good and readable , otherwise not consider for bid.

○ A2: Scope of Work

1. Deployment of one JCB/Pock lain machines (owned/hired), machines/vehicles (owned/hired) shall have valid RTO registration.
2. Scientific excavation of pond ash from ash so as to avoid formation of water bodies in bund.
3. Leading of trucks/bulkers/vehicles with pond ash along with proper tarpaulin as to avoid spillage of pond ash on road.
4. Assistance in proper movement of vehicles (Bulkers, trucks, tractors etc.) in and out of the ash bund of TPS.
5. Compliance of all pollution norms as prescribed by MPCB/CPCH/RTO etc as far as loading and transportation of pond ash is concerned. If any damage happens to MAHAGENCO properties, agency should be held wholly responsible for the same and damage will be recovered from the agency.
6. Weekly cleaning of spilled ash on ash bund approach roads.
7. Maintaining record of the pond ash lifting vehicles on daily basis with details such as:
  - i. Name of agency
  - ii. Vehicle/truck No
  - iii. Capacity of vehicle/truck/bulker (MT)
  - iv. Pond ash lifted quantity (MT)
  - v. Payment mode: cash/online etc.
8. Submission of pond ash lifting record containing all details mentioned at Sr.No.7 to TPS on daily basis
9. To sprinkle water on approach roads and in ash bund as per the instructions received from TPS officials
10. Prevention of excavation of pond ash by unauthorized agencies/persons.
11. Developing Ash bund surrounding area by means of Tree plantation, gardening etc
12. All qualifying bidders who matches with the rate of H1 bidder shall be allotted the proportionate of their bidding quantity.
13. Maintenance and repair of roads shall be in the scope of agency after the placement of order.

○ A3: Terms and Conditions

- 1) Contract period: - One year.
- 2) Bidders have to register on Metal Scrap Tarde Corporation Ltd(MSTC) portal for participation in e-auction.
- 3) Security Deposit: - Rs. 10 Lakh to H1 bidder & proportional to other successful bidders who matches with H1 as per their quantity allotment

- 4) EMD: - Rs.50000/-
- 5) Penalty: -If any agency fails to lift 80% of allotted quantity of pond ash, Penalty for Short Lifting at rate of Rs.10/MT for non-lifted quantity to be calculated quarterly.
- 6) Agency shall have to dispose of 50% of monthly allotted quantity given by TPS consecutively for the period of three months, failing which his order will be terminated, and the same quantity shall be offered to other successful bidders as per ranking.
- 7) All Bidders shall bid for min 100 MT and in multiple of 100 MT up to max quantity.
- 8) **The bidders who are presently lifting Fly Ash/POND Ash from Bhusawal TPS must clear their dues pending at Bhusawal TPS. If due found in scrutiny, the bidder will be disqualified.**

9) **Quantity Allocation Mechanism are :**

**A. General Principle**

- Allocation shall be done round wise based on bidder ranking.
- In each round, the rate of that round shall be tested with mandatory allocation of 25% quantity.
- The round shall be treated as successful only if at least one bidder accepts 25% quantity at the round rate, while the balance quantity 75% will be allocated proportionately to the bidding quantity of the bidders who matched the rate of the respective round.
- If a round fails, the rate of that round is scrapped, and only the bidder who quoted that rate is penalised.

**B. Round I (H1 Rate Round).**

1. After auction closure, bidders are ranked and the highest quoted rate bidder is identified as H1.
2. All bidders are informed that Round-I rate is H1 rate and are invited to:
  - o Match the H1 rate, and
  - o Lift quantity as per allocation rules.
3. The H1 bidder is mandatorily offered 25% of the total auctioned quantity at the H1 rate.

**Case 1:** If H1 accepts 25% quantity:

- O The H1 rate is declared as the final arrived rate.
- O 25% quantity is allotted to H1.

O The balance 75% quantity is allotted to other bidders who match the H1 rate,  
→ Proportionately based on their required / bid quantity.

O Round-I is closed successfully.

**Case 2:** If H1 does not accept, but any other bidder (H2 / H3 / ...) accepts 25% at H1 rate:

- O . That bidder becomes the effective H1 of Round-I.
- O . The H1 rate is declared as arrived rate.
- O . 25% quantity is allotted to that accepting bidder.

- O. Balance 75% is allotted proportionately to the bidding quantity of other bidders matching the H1 rate.
- O. Round-I is closed successfully.

**Case 3:** If H1 does NOT accept 25% quantity and no bidder matches the rate of round

- O. The H1 rate of Round-I is scrapped.

O. H1 bidder is penalised, namely:

- Immediate disqualification from the ongoing auction
- Forfeiture of EMD.
- Cancellation of any existing ash sale orders with MAHAGENCO (if applicable),
- Backlisting and Debarment from participation in MAHAGENCO ash auctions for a period of 03 years.
- Any ongoing MAHAGENCO ash contract, if existing, stands cancelled.

O. Other bidders are NOT penalised.

O. Auction proceeds to Round-II.

**C. Round II (H2 Rate Round):** (Applicable only if Round-I fails completely)

1. The H2 quoted rate becomes the Round-II rate. All remaining eligible bidders (H2 and below) are invited to:

- Match the H2 rate, and
- Accept mandatory 25% quantity.

2. The H2 bidder is mandatorily offered 25% quantity at H2 rate.

**Case 1:** If H2 accepts 25% quantity:

- O H2 rate becomes the final arrived rate.
- O 25% quantity is allotted to H2.
- O Balance 75% is allotted proportionately to other bidders matching the H2 rate.
- O Round-II is closed successfully.

**Case 2:** If H2 does not accept, but any lower bidder (H3 / H4 / ...) accepts 25% at H2 rate:

- That bidder becomes the effective H1 of Round-II.
- H2 rate is declared as the arrived rate.
- 25% quantity is allotted to the accepting bidder.
- Balance 75% is allotted proportionately to other bidders matching the H2 rate.
- Round-II is closed successfully.

**Case 3:** If H2 does NOT accept 25% quantity and no bidder matches the rate of round:

O. The H2 rate is scrapped.

O. Only H2 bidder is penalised:

- Immediate disqualification from the ongoing auction,
- Forfeiture of EMD.
- Cancellation of any existing ash sale orders with MAHAGENCO (if applicable),

- Backlisting and Debarment from participation in MAHAGENCO ash auctions for a period of 03 years.
- Any ongoing MAHAGENCO ash contract, if existing, stands cancelled.

O Other bidders are not penalised.

O Auction proceeds to Round-III.

#### **D. Subsequent Rounds (Round-III, IV, ...)**

- O. Each subsequent round shall follow the same sequence, where:
  - The next highest quoted rate becomes the round rate.
  - The bidder who quoted that rate is required to accept mandatory 25% quantity.
  - If accepted → rate arrives, quantity allotted (25% + 75%).
  - If not accepted → rate scrapped, only that bidder penalised, move to next round.
- O. The process shall continue round-over-round until:
  - A bidder accepts 25 % quantity at the applicable round rate , or
  - Auction reaches logical closure.

10) MSPGCL may alter the Qualifying Requirement / terms and Conditions/ Allocation Mechanism at any time. **MSPGCL have right to cancel the Auction at any time.**

11) Ash will be issued on Subject to Availability basis.

12) **MSPGCL reserves the right to make amendment /corrigendum or postpone e-auction wholly or partially without assigning reason thereof.**
