- No candidates will be allowed to enter the hall 30 minutes after the commencement of the examination.
- 8 Candidates will not be allowed to leave the examination hall during examination period.
- 9 Candidates are not alllowed to bring any handwritten or printed material except Companays prescribed books & circulars.
- ¹⁰ Misconduct and malpractice in any form could lead to disqualification of the candidate.
- ¹¹ Mobile phones are strictly not allowed in the examination hall, possession of mobile phone will lead to disqualification of the candidate.
- 12 Candidate should not write any indicative marking on the answer book for example "Shri Ganeshai Namah", "Hari Om" etc., any sign i.e. * ,#, \$, etc. If the candidate is found doing such mischief will disqualify from the exam process & liable for disciplinary action.
