- 2. The trainees will be under the control of Chief General Manager(HR), Nashik Training Centre for the period of theoretical training and will be monitored by him during the On Job Training.
- 3. These trainees will undergo Induction Level Training as per restructured Induction Level Training Plan. The details of the plan be communicated to the trainees at the Training Center.
- 4. Dress code for the training will be intimated to trainees after joining the training batch.
- 5. The training at Nashik Training Center is residential.
- 6. They will be entitled for TA/DA as per during study tour as per Company's Rules provided the study tour is undertaken to places other than Nashik.
- 7. After completion of the theoretical training, the trainee shall report to the power stations and shall undergo in-plant Training.
