



## **E-Auction NOTICE**

### **E-Auction for Sale of Pond Ash at Nashik TPS for FY 2025-26**

- 1.0** Tenders are invited through MSTC (e-auction) by the Chief Engineer, MSPGCL, Nashik TPS, Eklahare, Nashik from Reputed, Experienced and Registered Bidders those who are meeting Qualifying Requirements as under for the Sale of pond ash (60% quota) at Nashik TPS (On subject to availability basis).

**NAME OF THE WORK:**

Sale of Pond Ash (60% quota) at Nashik TPS for One Year.

**EARNEST MONEY:**

**Rs. 50,000/-**

(E-payment through any nationalized Bank)  
All Bidders found eligible after scrutiny will deposit EMD to MAHAGENCO. Only approved bidders having sufficient EMD with MAHAGENCO shall be able to participate in e-auction.

Total approximate quantity of pond ash available for lifting is 9 LMT at Nashik TPS. Further MSPGCL reserves the right to any change in declared quantity.

### **2.0 QUALIFYING REQUIREMENT**

1. The minimum annual turnover of Bidder during any of the last three years should be Rs. 1 crore.
2. Bidder should have experience in lifting and transportation of pond ash.
3. Bidder should have at least one JCB/Pock lain machine (Own/Hired). The machine/ vehicles (Own/Hired) shall have valid RTO registration.
4. Bidder should have PAN and GST certificate of business.
5. The lead bidder may form consortium with max. 3 no of other agencies to fulfill qualifying criteria
6. Q.R. of Sr No 1 and 2 is not applicable to bidders like local affected Gram panchayat/local bodies.
7. Q.R. of turnover is not applicable to Local agencies located within 50 KM radius of respective TPS

### **3.0 Scope of Work**

1. Deployment of one JCB/Pock lain machine (Own/Hired). The machine/ vehicles (Own/Hired) shall have valid RTO registration.
2. Scientific excavation of pond ash from ash to avoid formation of water bodies in bund.
3. Leading of trucks/bulkers/vehicles with pond ash along with proper tarpaulin as to avoid spillage of pond ash on road.
4. Assistance in proper movement of vehicles (Bulkers, trucks, tractors etc) in and out of the ash bund of TPS.
5. Compliance of all pollution norms as prescribed by MPCB/CPCH/RTO etc as far as loading and transportation of pond ash is concerned. If any damage happens to MAHAGENCO properties, agency shall be held wholly responsible for the same and damages will be recovered from the agency.
6. Weekly cleaning of spilled ash on ash bund approach roads.
7. Maintaining record of the pond ash lifting vehicles on daily basis with details such as:
  - i. Name of agency
  - ii. Vehicle/truck No
  - iii. Capacity of vehicle/truck/bulker (MT)
  - iv. Pond ash lifted quantity (MT)
  - v. Payment mode: cash/online etc.
8. Submission of pond ash lifting record containing all details mentioned at Sr.No.7 to TPS on daily basis
9. To sprinkle water on approach roads and in ash bund as per the instructions received from TPS officials
10. Prevention of excavation of pond ash by unauthorized agencies/persons.
11. Developing Ash bund surrounding area by means of Tree plantation, gardening etc.
12. All qualifying bidders who match the rate of H1 bidder shall be allotted the proportionate of their bidding quantity.
13. Maintenance and repair of roads shall be in scope of agency after placement of order.
14. Quantity allocation will be as below:
  - 70 % of the estimated quantity will be allotted to H1 bidder
  - 30 of the estimated quantity will be allotted to H2 bidder at H1 rate

### **4.0 Terms and Conditions**

- 1) Contract period :- One year from the date of issue of order
- 2) Security Deposit:- Rs. 10 Lakh
- 3) EMD :-EMD of Rs.50000/-

- 4) Penalty: -If any agency fails to lift 80% of allotted quantity of pond ash, Penalty for Short Lifting at rate of Rs.10/MT for non-lifted quantity to be calculated quarterly.
- 5) Agency shall have to dispose of 50% of monthly allotted quantity given by TPS consecutively for the period of three months, failing which his order will be terminated, and the same quantity shall be offered to other successful bidders as per ranking.

1. Mahagenco reserves the right to make amendment/corrigendum or postpone e-auction wholly or partially without assigning reasons thereof.

## **PRICE QUANTITY BIDDING METHODOLOGY**

1. Buyer needs to register on MSTC Portal and thereafter needs to submit registration documents and registration fee for activation of his account
2. After registration the buyer shall be able to login on the MSTC portal using his user id and password
3. Auction shall be hosted by MSTC, Auction shall have parameters like minimum qty, maximum qty, price increment, Pre Bid EMD amount etc
4. **Bidders are required to deposit Rs 50000/- to MAHAGENCO in Account details mentioned in auction catalogue.** Any qualifying document (if specified) in the bid document then the bidder needs to submit the same to MAHAGENCO/MSTC within the scheduled time period. On confirmation of their eligibility from MAHAGENCO, MSTC will inform bidders to their registered e-mails for submission of PRE BID EMD amount
5. On the scheduled date and time the auction starts.
6. For bidding, the bidder needs to enter the qty which he wants to bid and price per UOM(Unit of measurement) and needs to click on the bid button
7. Bidder cannot bid below the minimum qty, above which any bid qty should be a multiple of factor specified in the terms. The maximum qty allowable is limited by the maximum qty specified in the bid document.
8. Bidders cannot bid below the starting price. Bidders can bid on the start price and multiples of price which is specified in the auction terms.
9. System shall allow bidders to bid on a single price till the available qty is not exhausted.
10. Once the available qty is exhausted at a particular price, the bidder can bid at higher price for the qty as mentioned in point no 7. However such a bid will deallocate the quantity of previous allocation as per rules given at Point 11.
11. If Qty is exhausted then deallocation starts. Deallocation is done on the basis of Price, Qty and time basis
  - a) If qty is exhausted then first deallocation of qty is done from the bidder whose bid price is lowest.
  - b) If 2 or more than 2 bidders have the same lowest price then the system shall deallocate qty from the bidder whose qty is lowest. So if two or more bidders bid the same highest price then precedence will be accorded to the bidder who has placed the bid for the higher quantity so the bidder whose qty is lowest his qty is deallocated

- c) If 2 or more than 2 bidders have the same lowest price and same qty then the system shall deallocate qty from the bidder whose bid time is latest i.e. he placed bid in the last with reference to other bidders. So in case two or more bidders bid the same price and the same quantity, precedence will be given to the bidder who has offered his bid first with reference to time. So the bidder whose bid time is the latest his qty is deallocated
- d) There is a threshold qty below which no qty is allocated to any bidder during deallocation. So if for any deallocation remaining qty is going below threshold qty then the system shall not allocate that remaining qty to any bidder
12. On the bid floor bidder can see the residue qty, L1 Price, H1 Price and his allotted qty at that instant. If 2 or more bidders place the same bid, if qty is available then the system shall allocate qty to all the bidders, if qty available is sufficient for only one bidder then qty is allocated to that bidder who has placed their bid first with reference to time
13. Bidding shall continue in this way. Once bidding is completed then the system shall generate a Bid Sheet which has records of allocation to all the bidders
14. After the bid sheet all formalities are done by the buyer directly at MAHAGENCO's end
