

## SALE OF 20% OF POND ASH AT BHUSAWAL TPS

### ❖ Estimated Quantity and Rate.

1. Quantity available for allocation: 12,40,000 MT Pond Ash
2. Rate of Pond Ash: Rs. 100/ MT (exclusive of taxes) + Taxes as applicable.

### ❖ Qualifying requirements:

#### A: Project affected/land affected agencies/persons

1. Project affected/Land affected agencies/persons should have valid certificate about project affected due to BTPS.
2. GST Certificate of Business & Valid PAN , Aadhar card of owner.
3. Project affected/Land affected agencies/persons who have own Vehicles/Trucks shall be made eligible.
4. All vehicles shall have valid RTO registration and documents.
5. Only one (1) Poclain machine shall allow to deploy for pond ash lifting for the above allocated quantity and security deposit would be Rs. 10,00,000/- will be taken otherwise security deposit 1,00,000/- will be taken.
6. Bidder who is already lifting pond ash/working against previous E-auction shall not be considered eligible for this allocated quantity.

#### B: Local Brick Manufacturers:

1. Valid Consent to operate certificate from MPCB/CPCB for the Business.
2. If bidder is red brick manufacturer then valid NA certificate for the Business issued by appropriate Government authority (Jalgaon District).
3. GST Certificate of Business & Valid PAN , Aadhar card of owner.
4. DIC Certificate or Udyog Adhar or Permission from relevant government office for Business.
5. NOC from Grampanchayat/Municipality/Municipal Corporation.
6. Local Brick Manufacturers who have own Vehicles/Trucks shall be made eligible.
7. All vehicles shall have valid RTO registration and documents.
8. Only one (1) Poclain machine shall allow to deploy for pond ash lifting for the above allocated quantity and security deposit would be Rs. 10,00,000/- will be taken otherwise security deposit 1,00,000/- will be taken.
9. Bidder who is already lifting pond ash/working against previous E-auction shall not be considered eligible for this allocated quantity.

## ❖ Terms and Conditions

Contract period: - One year from the date of issue of order

1. Security Deposit: - If Poclain machine deploy for pond ash lifting for the allocated quantity then security deposit would be Rs. 10,00,000/- will be taken otherwise security deposit 1,00,000/- will be taken.
2. EMD: - EMD of Rs.10000/- All bidders found eligible after PQR will deposit EMD to MAHAGENCO. Only approved bidders having sufficient EMD with MAHAGENCO shall be considered for issuing of order.
3. Penalty: - If any agency fails to lift 80% of allotted quantity of pond ash, Penalty for Short Lifting at rate of Rs.10/MT for non-lifted quantity to be calculated quarterly.
4. Agency shall have to dispose of 50% of monthly allotted quantity given by TPS consecutively for the period of three months, failing which his order will be terminated.
5. Weighment of vehicles shall be done by weighing machine at specified place as per rule.
6. Scientific excavation of pond ash from ash so as to avoid formation of water bodies in bund.
7. In case project / land affected agencies/ persons or local brick manufacturers are more, then the available quantity uniform distribution will be made.
8. Loading of trucks/bulkers/vehicles with pond ash along with proper tarpaulin as to avoid spillage of pond ash on road.
9. Deployment of engaged labours for execution of the assigned work is in scope of bidder.
10. Assistance in proper movement of vehicles (Bulkers, trucks, tractors etc) in and out of the ash bund of TPS is in the scope of bidder.
11. Compliance of all pollution norms as prescribed by MPCB/CPCH/RTO etc as far as loading and transportation of pond ash is concerned. If any damages happens to MAHAGENCO properties, agency shall be held wholly responsible for the same and damages will be recovered from the agency.
12. Weekly cleaning of spilled ash on ash bund approach roads.
13. Proper monitoring and keeping watch round the clock (24\*7) at ash bund so as to avoid any malpractices.
14. Maintaining record of the pond ash lifting vehicles on daily basis with details such as:
  - i. Name of agency
  - ii. Vehicle/truck No
  - iii. Capacity of vehicle/truck/bulker (MT)
  - iv. Pond ash lifted quantity (MT)
15. Submission of pond ash lifting record containing all details mentioned at Sr.No.14 to BTPS on Weekly basis as & when required by BTPS.
16. The Chief Engineers of BTPS is empowered for the scrutiny and verification of project / land affected agencies/ persons or local brick manufacturers & issuance of sale orders thereof till full utilization of the quantities stated.
