

QUALIFYING REQUIREMENT

1. Bidder should be an ash product manufacturer (i.e. manufacturer of cement, bricks, cement sheets, Block, tiles, construction products, wall panels, cement sheets etc.) or should be ash processing, grinding units/Traders etc.
2. Bidder should produce relevant and valid licenses for their business (i.e consent to operate) from the Pollution Control Board of their respective area.
3. Bidder should submit the PAN, GST Certificate of its firm.
4. Those who are forming Joint Venture/ Consortium for this tender should follow following conditions:

a) Requirements for Proposals submitted by a Consortium.

The proposal submitted by a Consortium shall furnish the following details.


- a) The proposal shall contain detailed information of each of the members of the consortium.
- b) The proposal submitted by the consortium should include a description of the roles and responsibilities of individual members.
- c) A member of a particular consortium shall not be a member of any other consortium.
- d) One of the members shall be nominated as being in charge (Lead Member) and this authorization shall be evidenced by submitting a power of attorney signed by duly authorized signatories of the other Consortium members (As per format contained in the proposal document)
- e) The members of the consortium shall enter into a Memorandum of Understanding (MOU) for the purpose of submitting a proposal. The MOU shall interalia, also convey the intent to form a joint venture company which would enter into the Agreement and subsequently carry out all the responsibilities as stipulated in the Agreement. The MOU shall also clearly outline the proposed roles and responsibilities of each member at each

stage. A copy of the MOU shall be submitted with the proposal.

- f) The proposal shall be signed by the duly authorized signatory of the Lead member and shall be legally binding on all the members of the Consortium.
- g) All members of the Consortium shall be liable jointly and severally for the execution of the project in accordance with the terms of the Agreement and a statement to this effect shall be included in the authorization mentioned in (d) above, as well as in the Proposal and in the Agreement .
- h) All witnesses and sureties shall be persons of status and probity and their full names and addresses shall be stated below their signature. All signatures in the proposal documents shall be dated.

b) Changes in Consortium Composition

- a) Any change in the composition of a Consortium must be approved by MSPGCL in writing.
- b) The modified Consortium would be required to submit a revised Memorandum of understanding.
