B: For Group-II

○ B1: Qualifying requirement

1. Nature of Business: Bidder should be ash product manufacturer (i.e. manufacturer of bricks, sheets, blocks, tiles, construction products, wall panels, cement sheets etc.) with SSI/ DIC / Udyam registration certificate.
2. Bidder should produce relevant license for their business (i.e consent to operate) from Pollution Control Board of respective areas. Industries falling under White category shall be exempted from this condition only after producing the acknowledgement of self-declaration submitted to the MPCB thereby confirming to be in white category.
3. Bidders manufacturing unit should be located within 300 KM radius of respective TPS.
4. Undertaking regarding purpose of use of fly ash.
5. Map showing the distance of manufacturing unit/plant of applicant from TPS.
6. If bidder is red brick manufacturer, then valid NA certificate for the Business issued by appropriate Government authority (Respective District).
7. GST Certificate of Business, Aadhar card of owner.
8. DIC Certificate or Udyog Adhar or udyam registration certificate or Permission from relevant government office for Business.
9. NOC from Gram panchayat/ Municipality/ Municipal Corporation.
10. All vehicles shall have valid RTO registration and documents.
11. Any bidder/ agency already lifting pond ash under the Group-I and Group-III quota will not be entitled for participation in group-II.

○ **B2: Scope of Work**

1. Deployment of one JCB/Pock lain machines (owned/hired), machines/vehicles (owned/hired) shall have valid RTO registration.
2. Scientific excavation of pond ash from ash so as to avoid formation of water bodies in bund.
3. Leading of trucks/bulkers/vehicles with pond ash along with proper tarpaulin as to avoid spillage of pond ash on road.
4. Assistance in proper movement of vehicles (Bulkers, trucks, tractors etc) in and out of the ash bund of TPS.
5. Compliance of all pollution norms as prescribed by MPCB/CPCH/RTO etc as far as loading and transportation of pond ash is concerned. If any damages happens to MAHAGENCO properties, agency shall be held wholly responsible for the same and damages will be recovered from the agency.
6. Weekly cleaning of spilled ash on ash bund approach roads.
7. Maintaining record of the pond ash lifting vehicles on daily basis with details such as:
 - Name of agency
 - Vehicle/truck No
 - Capacity of vehicle/truck/bulker (MT)
 - Pond ash lifted quantity (MT)
 - Payment mode: cash/online etc.
8. Submission of pond ash lifting record containing all details mentioned at Sr.No.7 to TPS on daily basis
9. To sprinkle water on approach roads and in ash bund as per the instructions received from TPS officials
10. Prevention of excavation of pond ash by unauthorized agencies/persons.
11. Developing Ash bund surrounding area by means of Tree plantation, gardening etc
12. All qualifying bidders who matches the rate of H1 bidder shall be allotted the proportionate of their bidding quantity.
13. Maintenance and repair of roads shall be in the scope of agency after the placement of order.

○ **B3: TERMS AND CONDITIONS**

1. Contract Period: One Year
2. EMD: Rs. 10,000 /-
3. Security Deposit: - 5 % of the annual order value limited to Rs. 1 Lakh
4. Penalty: If any agency fails to lift 80% of allotted quantity of pond ash, Penalty for Short Lifting at rate of Rs. 10/MT for non-lifted quantity to be calculated quarterly.
5. Agency shall have to dispose of 50% of monthly allotted quantity given by TPS consecutively for the period of three months, failing which his order will be terminated
