This is in reference to Tender No. CE/FM/EE2/RcR-KPKD/21643 Rfx No.3000021643 published on 18.11.2021 & Corrigendum published on 30.11.2021 for the work of raw coal transportation of 10 LMT per annum by Road cum Rail (RcR) mode from Kusmunda/Gevra/Dipka mines of SECL to Mahagenco TPS. As decided by the Competent Authority tender document has been revised.as below :

**i) Original tender Clause 1.12 (V) Railway Siding is as follows:**

Bidder should have permission / consent of Maheshwari Coal Benefication and Infra Pvt. Ltd. Siding (MMBD Siding) owner to operate the siding on SECR Bilaspur division for dispatch of coal to All TPS of Mahagenco.

Permission / consent of MMBD siding owner to operate the siding should be submitted along with the bid, failure which the bid will not be considered. The siding should be available for the entire period of the contract.

**Revised Tender Clause 1.12 (V) Railway Siding is as follows:**

Permission/Consent/NOC from Maheshwari Coal Benefication and Infra Pvt. Ltd. Siding (MMBD Siding) is not required at the time of bid submission but Permission/Consent/NOC for the same shall have to be submitted by the bidder before opening of price bid.
